

Hiring of Retired School Employees

The district shall recruit, select and employ the best-qualified individuals as employees. The district may employ persons retired from the Teachers' Retirement System (TRS), the School Employees' Retirement System (SERS) or the Public Employees' Retirement System (PERS). A retired employee shall only be rehired pursuant to this operational procedure.

1. All Retirees

All retirees of TRS, SERS or PERS may work an annual threshold of eight hundred sixty-seven (867) hours per year while receiving retirement benefits. The annual threshold for TRS Plan 1 retirees is calculated per fiscal year. All other plans are calculated per calendar year. Qualified hours are determined by whether the retiree works in an eligible position as defined by the Department of Retirement Systems (DRS).

2. TRS 1 and PERS 1 Retirees (hired after July 22, 2007)

Beyond the eight hundred sixty-seven (867) hours per work year, eligible retirees hired from Plan I of TRS or PERS may work up to a total of one thousand five hundred (1,500) hours per year while receiving retirement benefits, subject to limitations established by DRS.

3. District Responsibilities

The district shall abide by the following process when considering a retiree for employment:

- 3.1 Applicant(s) shall be evaluated and considered equally, selecting the candidate who best meets the needs of the district.
- 3.2 There shall be no prearranged employment agreement or commitment to rehire an employee after retirement. Mere inquiries about post-retirement employment do not constitute an agreement.
- 3.3 Employment shall be limited to a maximum of a one (1) year, non-continuing contract or appointment.
- 3.4 The district shall make contributions to the appropriate retirement system when any retiree works more than eight hundred sixty-seven (867) hours per year.
- 3.5 The district shall maintain records of the process followed in seeking qualified candidates that resulted in the hiring of the retiree.
- 3.6 The Board of Directors shall approve the hiring and the district documentation for choosing the retiree.
- 3.7 Subject to any applicable bargaining agreements, vacancies filled by retirees shall be annually reviewed by the superintendent's designee to determine whether the retiree will be rehired for another year of employment.
- 3.8 The district shall provide the retiree with the same terms and conditions of employment as other appointees or employees in comparable positions with the exception of sick-leave cash-out.
- 3.9 The district shall report the number of hours worked by the retiree to DRS.

4. Retired Employee Responsibilities

The following conditions of employment shall apply to retirees that are re-employed:

- 4.1 Retired applicants shall disclose to the district whether they are retired from a Washington state retirement plan.
- 4.2 Employees must satisfy the DRS requirement for separation and retirement from service prior to accepting a retire/rehire position with the district.
- 4.3 Retirees are subject to the same collective bargaining membership as other one (1) year temporary employees.
- 4.4 Retirees are responsible for tracking service hours during post-retirement employment among multiple employers.
